



State Aid Scoreboard 2017:

Results, trends and observations regarding EU28 State Aid expenditure reports for 2016

1. INTRODUCTION

Under Article 6(1) of Commission Regulation (EC) 794/2004, the Commission has to publish, annually, a State aid synopsis ("State Aid Scoreboard") on the basis of the expenditure reports provided by Member States.

This note is an internal report that presents State aid expenditure data for 2016 as reported by Member States¹ and summarises the main findings by focusing on the most relevant observed changes between 2015 and 2016.

Expenditure refers to all existing aid measures to industries, services, agriculture and fisheries, for which the Commission adopted a formal decision or received a summary information sheet from the Member States in relation to measures qualifying for exemption under the General Block Exemption Regulation (GBER). The figures do not include funding granted in line with the *de minimis* rules since this spending is not deemed to constitute State aid. The figures provided also exclude most of the aid to railways and services of general economic interest. Also, crisis aid to the financial sector is dealt with separately in [section 4](#).

In addition, the note includes an analysis of reported expenditure under all dimensions of reporting and demonstrates the benefits and the effects of State Aid Modernisation and the role of State aid in steering public aid towards objectives of common interest that otherwise would not be realised (e.g. R&D&I and investment in renewable energy), while ensuring benefits for society and minimising the negative impact of State aid on competition.

Finally, the overall observations are underpinned by further information. The [Annexes](#) provide additional material (illustrative tables and charts) to allow a more informed reading of the 2017 Scoreboard results. In particular [Annex 6](#) contains country fiches, which have been shared with Member States for consultation and verification of the reported expenditures. The country fiches contain the final figures to be published.

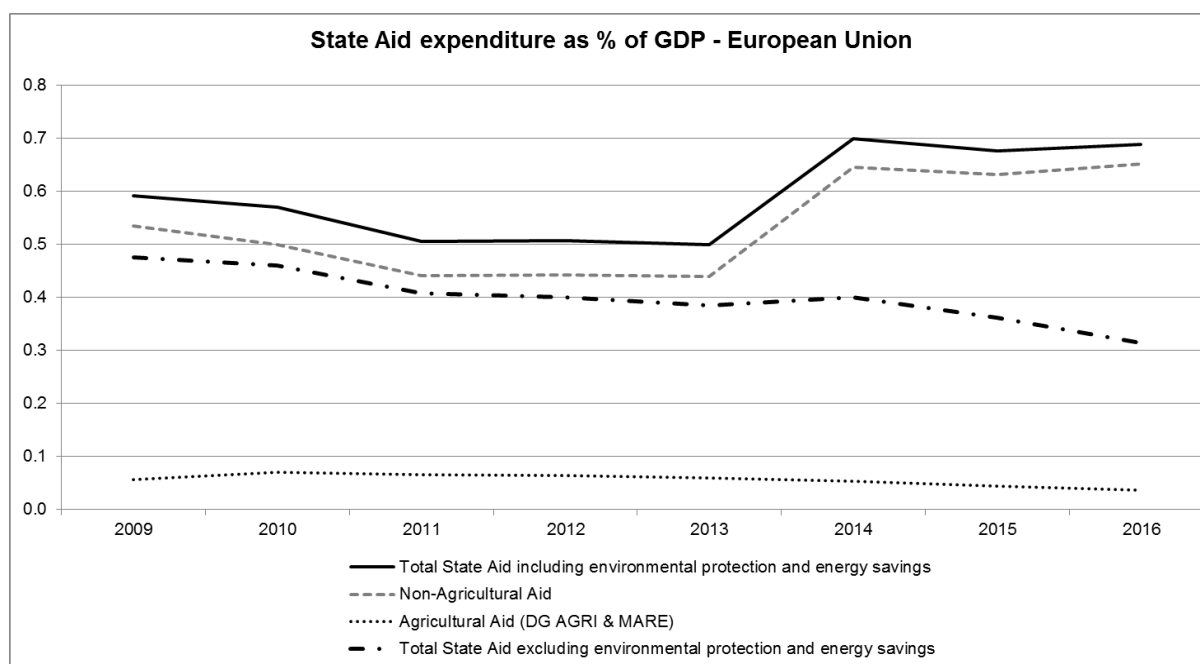

2. OVERALL TRENDS

2.1. Total State aid expenditure

According to the national expenditure reports for 2016², **State aid spending increased in 2016** both in absolute amounts and relative to GDP. Member States spent EUR 102.8 billion, i.e. 0.69% of GDP, on State aid at European Union level (see [Graph 1](#)), an increase of about 0.01p.p. of GDP compared to 2015. In nominal terms, this represents an increase of about 2.6% compared to 2015 expenditures (+ EUR 2.6 billion).

Note: A large part of the increase in reported total expenditure that has been observed from 2014 compared to previous years was due to the inclusion of renewable energy schemes (RES).

Please note that some Member States have not yet reported all the equivalent measures on Renewable Energy Sources (RES)/Combined Heat and Power (CHP). Moreover, in some cases, the reporting has been made only for 2014 and/or following years while the measures may well also cover previous years. In light of the jurisprudence, we may therefore expect in the future a more consistent and continuous reporting of State aid to renewables.

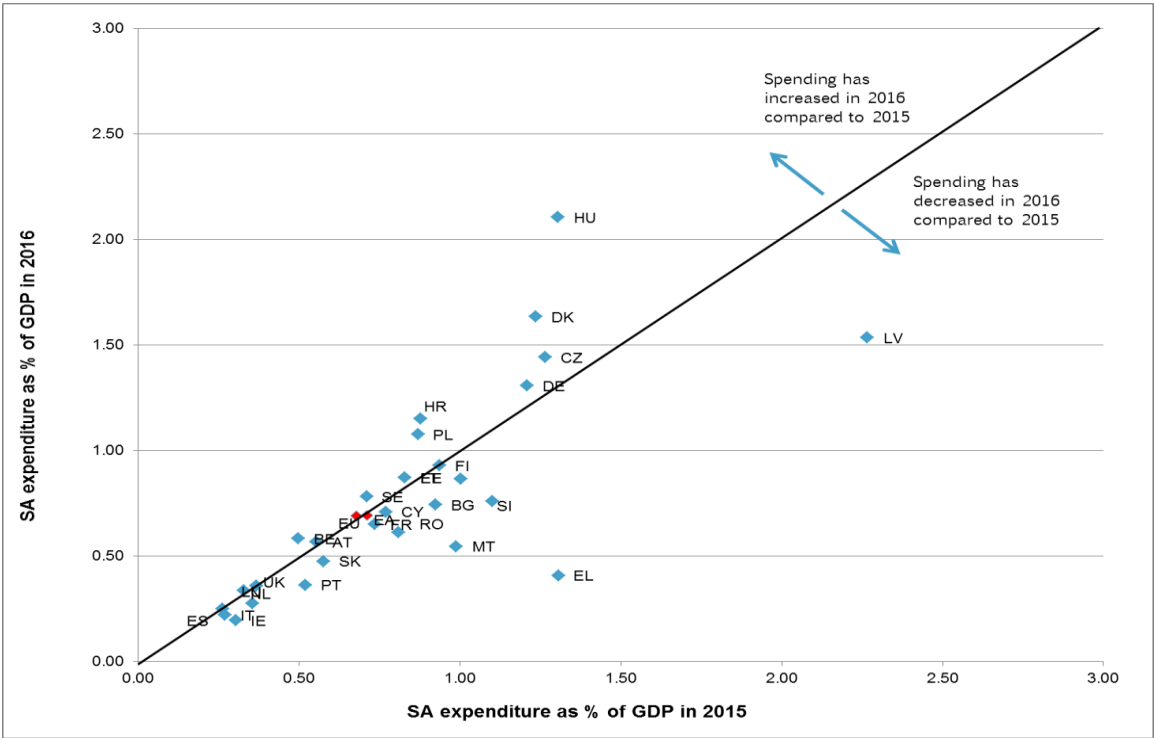
In 2016, spending was reported for 3014 active measures of which a large majority of schemes (76%). While only about 13% of these measures (i.e. 315 cases) concerned environmental protection and energy savings, they cover, on average, much higher budgets and spending as compared to other objectives. **About 54% of total spending was attributed to State aid to environmental and energy savings.** A large share of current State aid spending for environmental and energy savings is due to the approval under EU State aid rules of numerous renewable energy initiatives in many Member States to help them meet their energy security and

environmental goals (e.g. 20% by 2020 and 27% by 2030³) and to achieve the Energy Union strategy on the transition to a low-carbon, secure and competitive economy. In that context, our State aid rules make sure that the transition will be socially-fair and consumer-centred. **Without State aid to environmental and energy savings**, Member States spent about EUR 46.9 billion, i.e. 0.31% of GDP, on State aid at European Union level (see [Graph 1](#)). In nominal terms, this represents a **decrease of about 12.6% compared to 2015 expenditure** (- EUR 6.8 billion)⁴.

As regards both levels and changes in total expenditure, **large differences between Member States** can be observed (see [Graph 2](#) and [Annex 2](#)). The highest increase in expenditure is recorded in Hungary (+0.8p.p. of GDP). Other Member States, i.e. Denmark (+0.4p.p. of GDP), Croatia (+0.3p.p. of GDP), Poland and the Czech Republic (+0.2p.p. of GDP) also recorded large increases. On the contrary, a substantial reduction in State Aid expenditure has been observed in Greece (-0.9p.p. of GDP), Latvia (-0.7p.p. of GDP), Malta (-0.4p.p. of GDP), Slovenia (-0.3p.p. of GDP), Romania, Bulgaria and Portugal (-0.2p.p. of GDP).

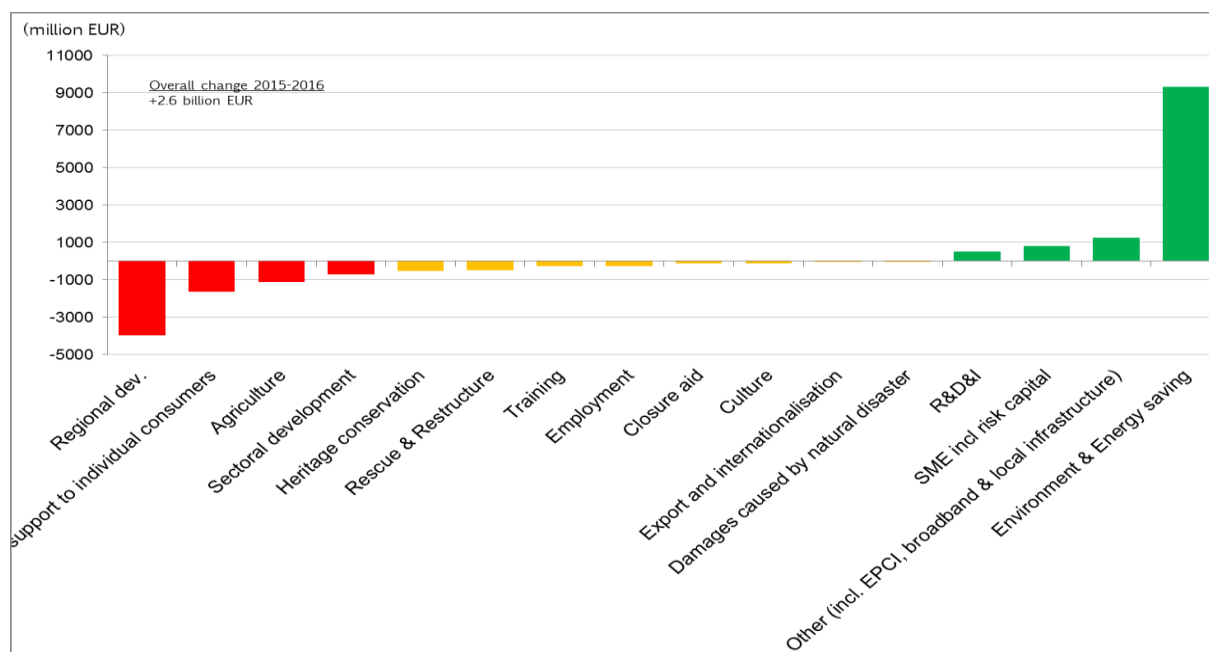
³ The EU's Renewable energy directive sets a binding target of 20% final energy consumption from renewable sources by 2020. To achieve this, EU Member States have committed to reach their own national renewables targets ranging from 10% in Malta to 49% in Sweden. Additionally, EU Member States have already agreed on a new renewable energy target of at least 27% of final energy consumption in the EU as a whole by 2030 as part of the EU's energy and climate goals for 2030. ⁴ When comparing State Aid expenditure as % of GDP for the two last four years period, i.e. 2009-2012 and 2013-2016, the trend shows a clear decrease of about 0.07% of GDP (with respectively a total expenditure of about 0.44% and 0.37% of GDP for the two selected periods).

2.2. State aid expenditure by objective

At EU level, the observed overall change in reported State Aid expenditure in 2016 compared to 2015 largely differs by specific policy objectives (see [Graph 2](#) and [Annex 3](#)).

In particular, the largest variations, in nominal terms, have been registered for the following objectives:

(1) An **increase of State aid to environmental protection including energy savings** of about 9.3 billion EUR. In absolute amounts, the most noticeable increases, compared to 2015, have been registered in Germany (+4 billion EUR), the Czech Republic (+ 1.2 billion EUR), Denmark (+1.2 billion EUR), France (+1.1 billion EUR), the United-Kingdom (+601 million EUR) and Sweden (+450 million EUR). They correspond to increases in spending and the introduction of new schemes to support renewables (Germany (SA.38632), the Czech Republic (SA.40171) and the United-Kingdom (SA.32125)), to achieve energy savings through Combined Heat and Power (Germany (SA.42393)) or through specific tax reimbursement or incentive mechanisms (Denmark (SA.42897), France (SA.43468) and Sweden (SA.4330)).

(2) A **decrease of State aid for regional development** of about 4 billion EUR at EU level. The decrease was observed in particular in Greece (-1.7 billion EUR), France (-1.1 billion EUR), the Czech Republic (-882 million EUR), the United-Kingdom (-544 million EUR) and Portugal (-267 million EUR). On the contrary, State aid spending for regional development increased in Poland (+652 million EUR), Hungary (+334 million EUR) and Germany (+241 million EUR). For Greece, the change is fully due to a reclassification of the guarantees paid by the Greek Government for loans granted to public sector firms and organisations as Services of General Economic Interest. For France, the decrease is due to the absence of reporting in 2016 for the measure

concerning specific tax exemptions for employer contributions in outermost regions (SA.41040). The other changes are largely due to the still on-going transition between measures that were adopted under previously applicable rules and those adopted under the new 2014-2020 Regional Aid Guidelines and GBER, knowing that the scope (e.g. broadband), the eligible regions and the allowed aid intensities to ensure the proper targeting of regional aid towards the weakest regions have changed strongly.

(3) A **decrease of State aid for social support to individual consumers** of about 1.6 billion EUR that was observed in France following the expiry of measure SA.38362 that allowed, before 2016, to tax exempt certain types of contributions to group health insurances.

(4) An overall **increase of State aid to other objectives including broadband, Projects of Common European Interest or local infrastructures** of about 1.2 billion EUR that was mostly due to the increases registered in Belgium (+392 million EUR), Germany (+296 million EUR), Hungary (+170 million EUR) and Italy (+140 million EUR). These increases concern new schemes covering very disparate objectives ranging from an excess profit tax ruling system (Belgium (SA.37667)) to cross-sectorial cooperation (Germany (SA.46338)) and broadband infrastructures (Hungary (SA.39836) and Italy (SA.41647)).

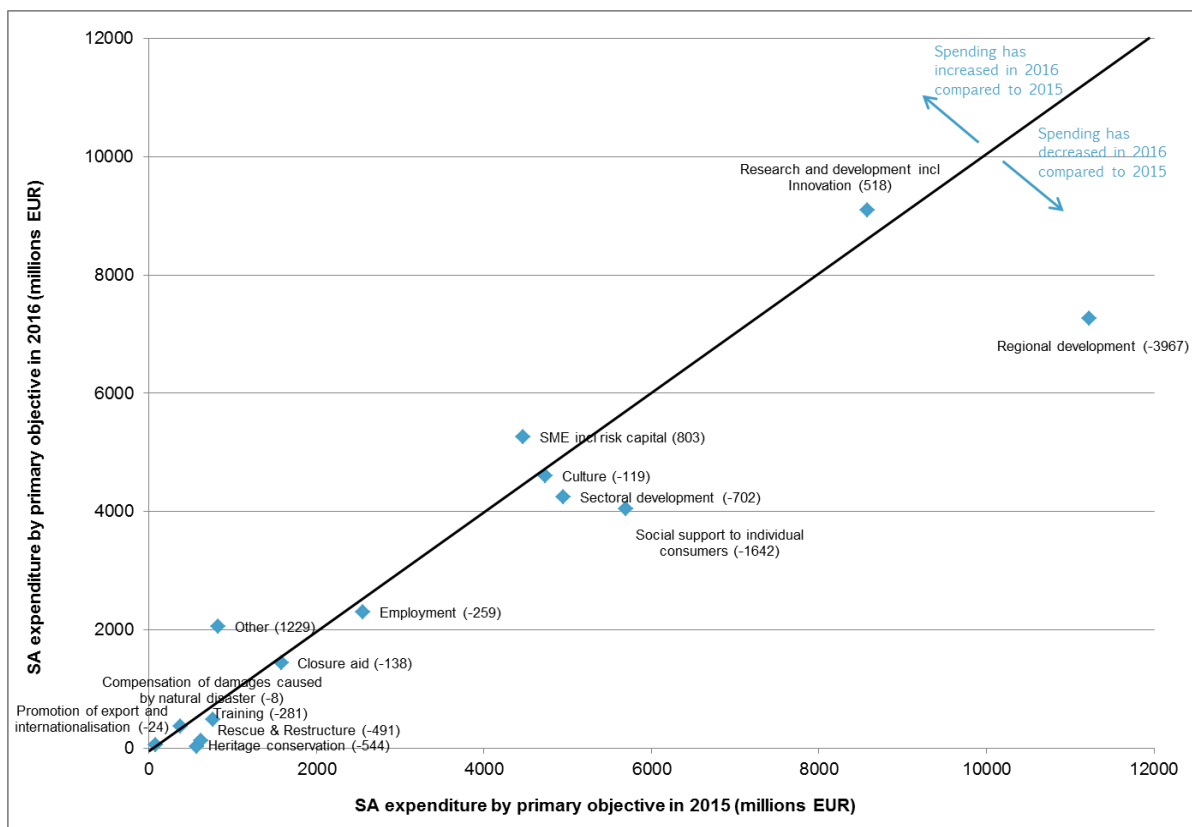
(5) A **decrease in aid to the agricultural and forestry sectors** of about 1.1 billion EUR that was mostly due to a strong decrease in a few Member States, notably Italy (-740 million EUR) and Ireland (-219 million EUR) that compensated for the increase observed in a few Member States such as Germany (+154 million EUR) and the Netherlands (+70 million EUR). It therefore appears that, as a consequence of the EU's common agricultural and rural development policies, total spending on agricultural aid has steadily decreased over the last five years by more than 600 million EUR per year (See [Graph 1](#)).

(6) An **increase of State aid for SMEs** of about 1.1 billion EUR that occurred in 2016 notably in the United-Kingdom (+823 million EUR) and France (+235 million EUR). For the United-Kingdom, this concerns a big enterprise growth fund (SA.36854) offering grants and loans to businesses within the Derby and the Travel to Work Area, while for France it is due to a scheme aiming at encouraging investment in innovative SMEs through exceptional depreciation of investment by businesses (SA.41265).

(7) An **increase of State aid on research and development including innovation** of about 0.5 billion EUR that was observed to a very large extent in Italy (+249 million EUR), Hungary (+ 246 million EUR) and Poland (+ 229 million EUR). In a context of strong global competition, State aid rules seem to be flexible enough to allow for aid that is sufficiently high and is awarded where it is needed for projects supporting research, development and innovation benefitting both large and small companies.

The figures reported for the remaining aid objectives in 2016 are on the contrary broadly similar to those in 2015 (see [Graph 4](#)).

In general terms, State aid control does not prevent Member State governments from supporting their own legitimate policy objectives and priorities. The 2017 Scoreboard highlights that Member States used State aid for rather different objectives (see [Graph 5](#)). In 2016, **the prime reported policy objectives** were:

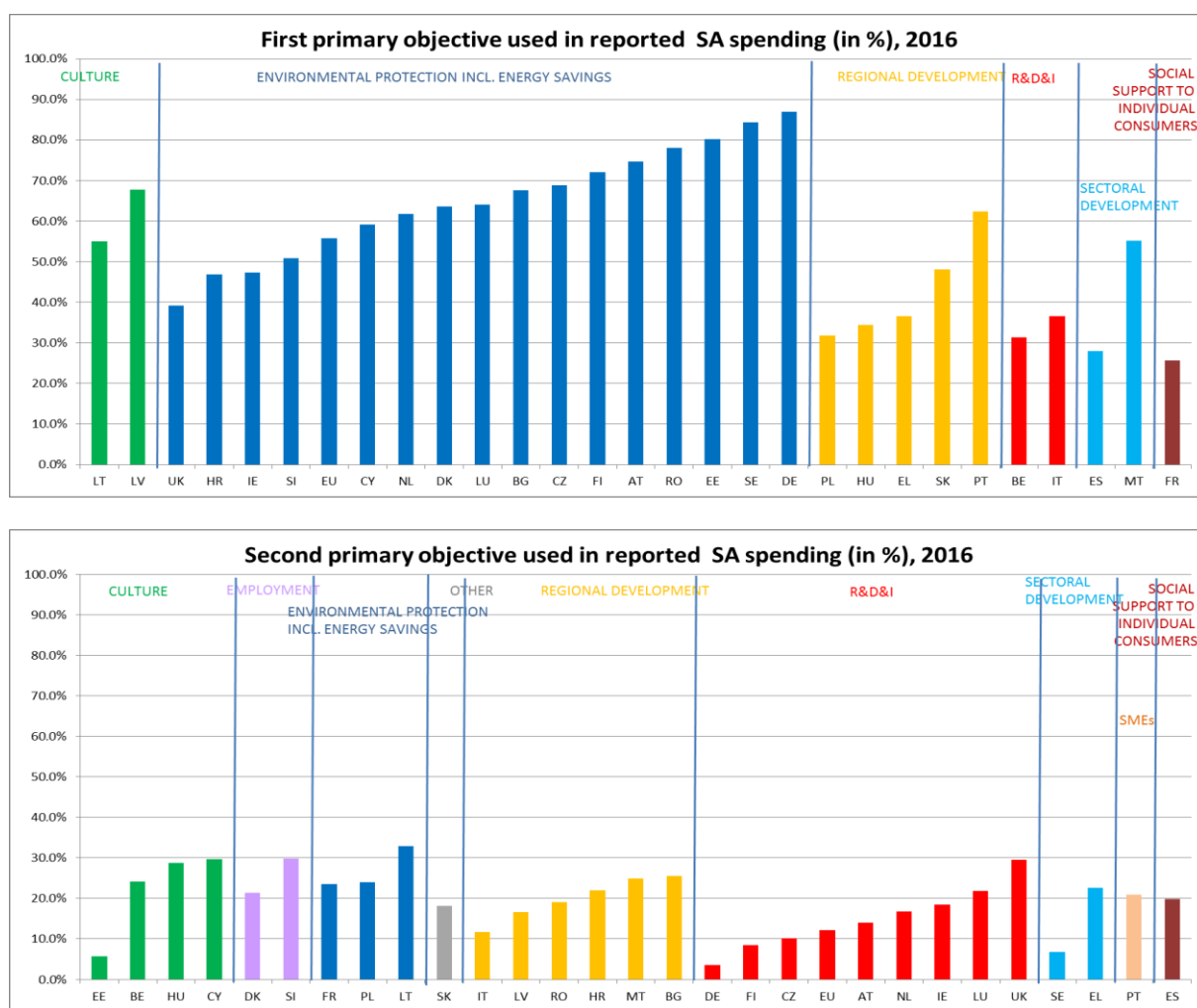
- A majority of 16 Member States (Germany, Sweden, Estonia, Romania, Austria, Finland, the Czech Republic, Bulgaria, Luxembourg, Denmark, Netherlands, Cyprus, Slovenia, Ireland and Croatia) spent State aid mostly for **environmental protection and energy savings**;
- **Regional development** was the main used objective in Poland, Hungary, Greece, Slovakia and Portugal;
- **Research, development and innovation** the prime objective in Belgium and Italy;
- **Culture** the main objective in Lithuania and Latvia;
- **Sectoral development** in Spain and Malta;
- **Social support to individual consumers** in France.

In some Member States, the spending was very concentrated on one single main objective. 13 Member States spent more than 60% of their total State aid spending on one main policy objective (Latvia, Netherlands,

Denmark, Luxembourg, Bulgaria, Czech Republic, Finland, Austria, Romania, Estonia, Sweden, Germany and Portugal).

When considering the two main objectives, i.e. the prime and the second, for which each Member State spent the most in 2016, **environmental protection and energy savings** appeared in 19 Member States, followed by **regional development** in 11 Member States and **research, development and innovation** in 10 Member States (See [Graph 5](#)).

Graph 5 – Biggest shares (first and second) of spending per primary objective by Member State in 2016 (%)



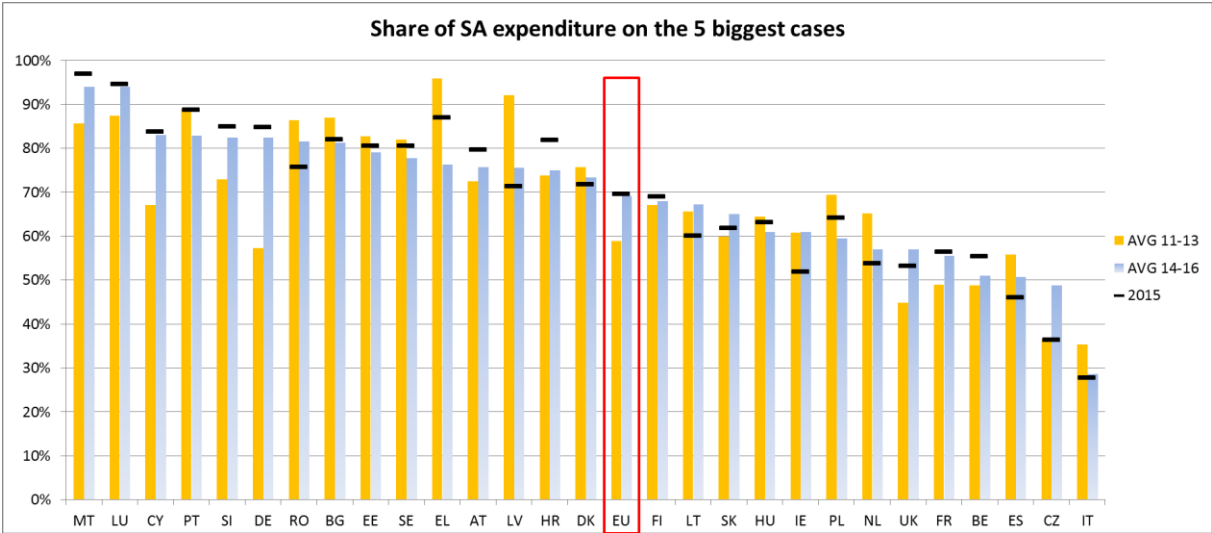

2.3. State aid expenditure by measure

In line with the above findings, the share of State aid expenditure used for the 5 measures for which the reported expenditure was highest in each Member State tends to increase. It indicates the **inclination of Member States to set up a limited number of big schemes or measures that absorb most of the State aid spending**. On average, **more than 70% of total spending was concentrated on the five biggest measures in 2016** (see [Graph 6](#)). In 15 Member States (Bulgaria, the Czech Republic, Denmark, Germany, Estonia, Croatia,

Cyprus, Latvia, Lithuania, Luxembourg, Malta, Austria, Romania, Slovenia, Sweden), this share was even above 75%. This development is related to the fact that notified measures tend to cover bigger budgets and spending than in the past, although it is also highly correlated to the size of the Member State or its institutional structure.

To complement the overview provided above, [Table 1](#) highlights, for each Member State, the objectives for which expenditure has most increased or decreased in both relative and absolute terms in 2016 compared to 2015. [Table 2](#) provides a more disaggregated perspective at the level of the relevant State aid measure and lists the 30 cases for which expenditure has increased or decreased the most significantly as % of GDP in 2016 compared to 2015. Additionally, [Annex 1](#) provides the same relevant information by main primary policy objective. For example, the decrease observed in 2016 compared to 2015 in total State aid expenditure on rescue and restructuring (R&R) is mostly due to no spending and the expiry of the R&R aid to British energy plc. Moreover, the absence of R&R spending for Air Malta plc explains the substantial reduction in total State Aid expenditure of 0.4p.p. of GDP observed for this Member State (see Annex 1.9). These idiosyncratic developments reflect large differences across Member States in the way they use State aid for attaining policy objectives.

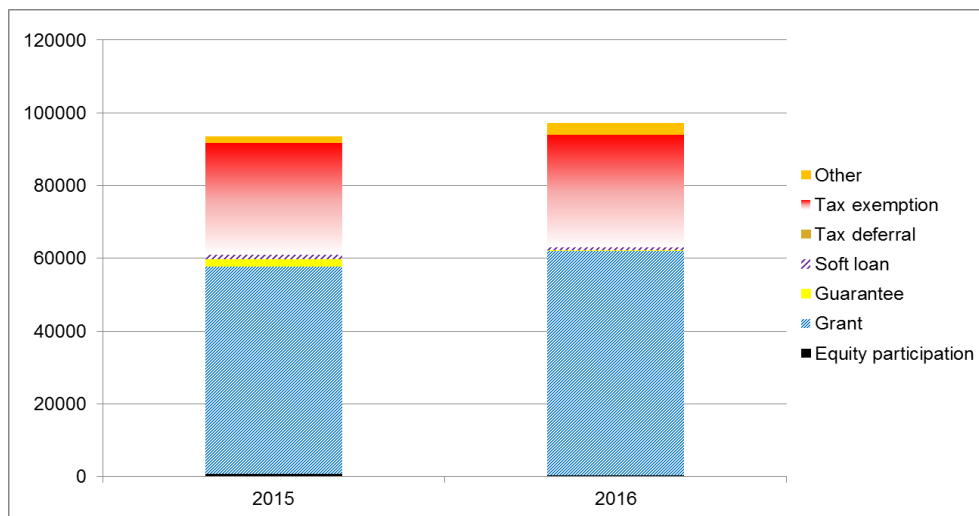

2.4. State aid expenditure by instrument

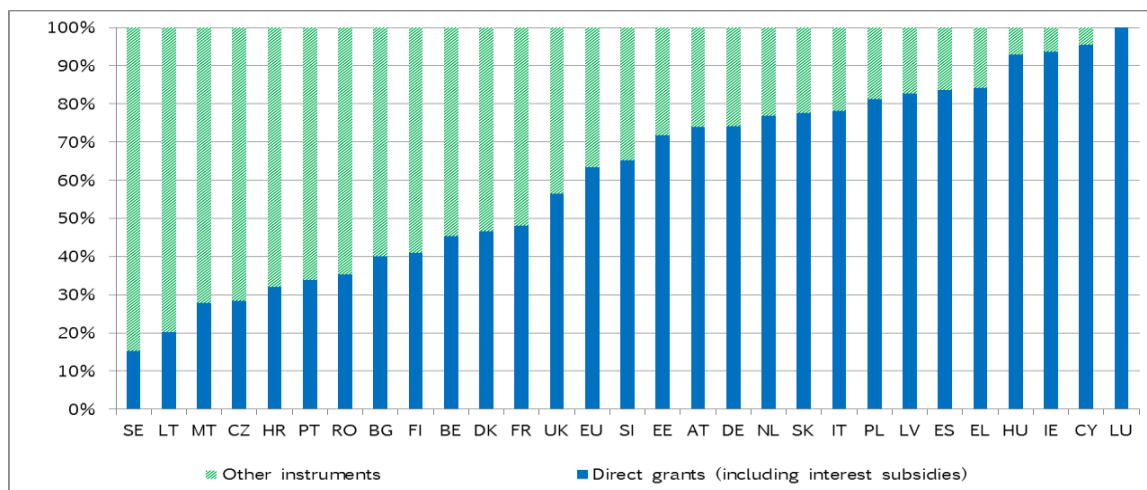
Looking at expenditure by aid instrument ([Graph 7](#)), **grants including interest subsidies remain the most popular aid instrument** (63% of total expenditure) followed by tax exemptions (32% of total expenditure). Compared to 2015 and 2014, the shares of spending by instrument have remained rather stable at EU level. However, **practices among Member States largely differ**: for example, direct grants cover less than 50% of country specific aid payments in 12 Member States (Sweden, Lithuania, Malta, the Czech Republic, Croatia, Portugal, Romania, Bulgaria, Finland, Belgium Denmark and France) (see [Graph 8](#)).

Graph 8 – Share of total State aid expenditure, excluding Agricultural Aid, disbursed through direct grants (including interest subsidies) and through other instruments in 2016

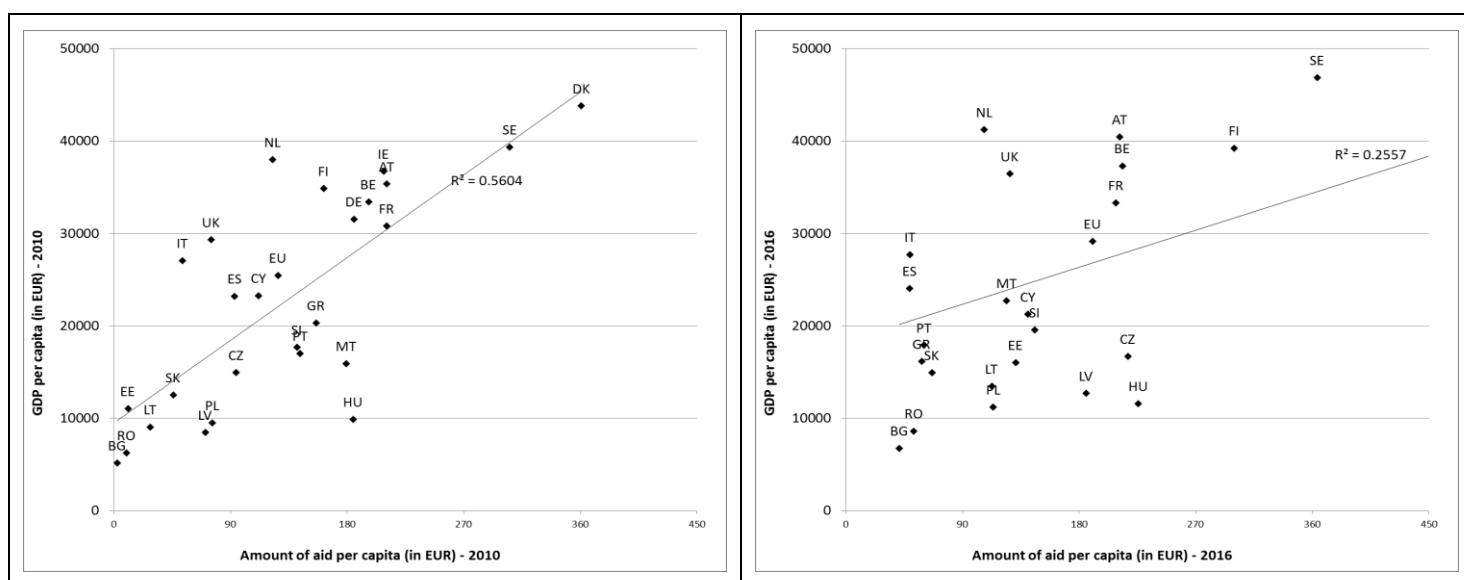

2.5. State aid expenditure on co-financed projects

There is a clear link between State aid rules and in particular regional aid rules and the EU economic and social cohesion policy. If richer Member States were allowed to support their domestic industries in an unrestrained manner, this would undermine the effectiveness of European Structural and Investment Funds support to the weaker Member States and regions and thereby impair the elimination of disparities in and further integration of the Single Market. State aid control helps to make aid more effective by using regional aid sparingly and proportionately, concentrating it on the most disadvantaged regions to induce additional investment or economic activity in those areas. Data shows that the correlation between State aid spending per capita and GDP per capita more than halved between 2010 and 2016 ([Graph 9](#)), highlighting also in particular that the State Aid Modernisation did not lead to any extra ‘deep-pockets distortions’.

Regarding the **total State aid spending on co-financed projects**, since 2014, Member States must report the total amount of aid that is co-financed including both national and EU Structural Funds expenditure⁵.

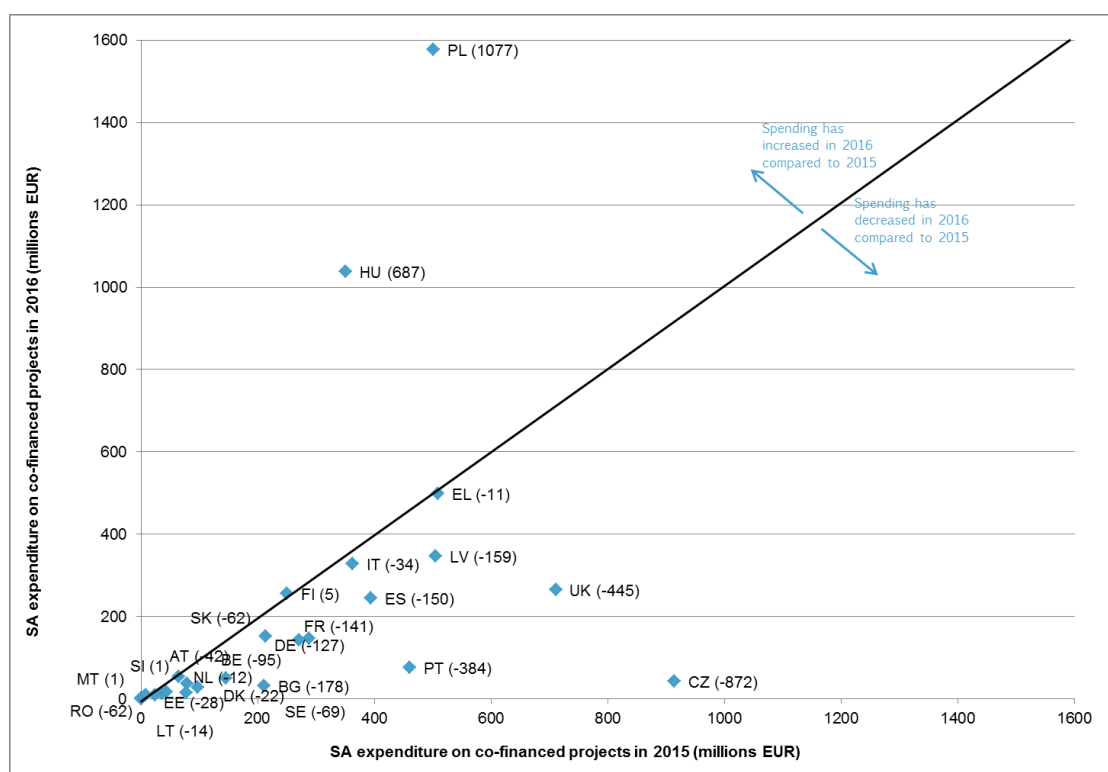
Since 2014, total spending on co-financed projects, excluding agricultural aid, has **decreased** progressively from about 8.6 billion EUR in 2014 to about 5.4 billion EUR in 2016 of which respectively 75% came from EU funds and 25% from purely national funds. In 2016 and compared to 2015, total reported spending for co-financed projects decreased by about 1.1 billion EUR. The strongest decreases were recorded in the Czech Republic (-872 million EUR), the United-Kingdom (-445 million EUR), Portugal (-384 million EUR), Bulgaria (-178 million EUR) and Latvia (-159 million EUR); decreases were also recorded in 15 other

Member States (See [Graph 10](#)). On the contrary, spending on co-financed projects increased substantially in Poland (+1.1 billion EUR) and Hungary (+687 million EUR).

The range of EU programmes that are currently subject to State aid rules is limited, since EU programmes managed at EU level (i.a. COSME, H2020, CEF) include a State aid consistency requirement. However, more than half of EU funding is channelled through 5 European structural and investment funds (ESIF) in decentralised management⁶ and therefore subject to State aid control, unless it relates to non-economic activities or infrastructure projects (mostly outside the scope of the State aid rules). Since, at EU level, the average annual budget of the relevant programmes⁷ under both the 2007-2013 and 2014-2020 programming periods amounts to about 65 billion EUR, the share of annual EU funding subject to State aid control represented only **about 10% on average** over the period 2014-2016.

3. IMPACT OF THE STATE AID MODERNISATION (SAM)

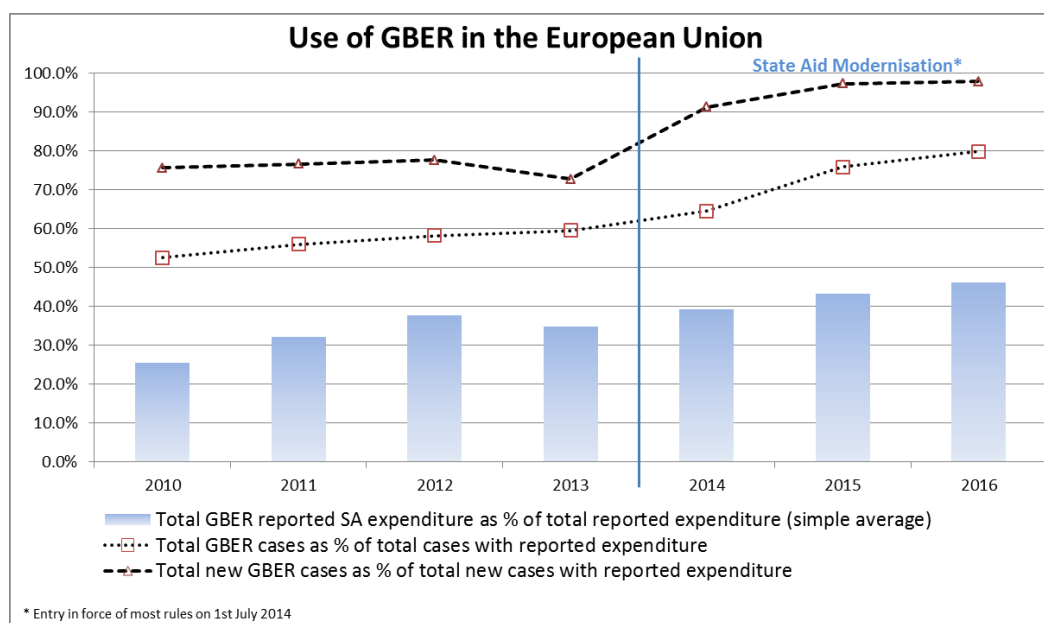
A major reform package called **State Aid Modernisation (SAM)** was introduced in July 2014 allowing Member States to quickly implement State aid that fosters investment, economic growth and job creation, leaving the Commission to focus its State aid control on cases most liable to distort competition. SAM is a change in governance of EU State aid policy that allows better allocation of public resources and promotes higher efficiency and better quality of policy interventions. Among the key objectives of the reform are tangible cuts in red tape, the promotion of a better use of limited public resources by Member States and of a higher contribution of aid measures to growth.

The 2017 Scoreboard shows the benefits of modernisation.

3.1. GBER uptake

More than **97% of new measures** for which expenditure has been reported for the first time fell under the **General Block Exemption Regulation** in 2016, i.e. an **increase of about 25p.p. compared to 2013** (see [Graph 11](#)). Looking at all measures for which expenditure has been reported (and not only new measures), about 80% of all measures were block exempted in 2016, an increase of respectively about 4% and 20%, compared to 2015 and 2013. In terms of spending, total expenditure on GBER measures in the EU represented about 31 billion euros in 2016, i.e. about 32% of total expenditure. However, when considering a simple average to reflect equally differences in Member States practice, it appears that, in 2016, **Member States spent on average about 46 % of the total spending on GBER measures**, an increase of about 11p.p. compared to 2013.

Graph 11 – Use of GBER in State aid measures for which expenditure has been reported in the EU, 2010-2016

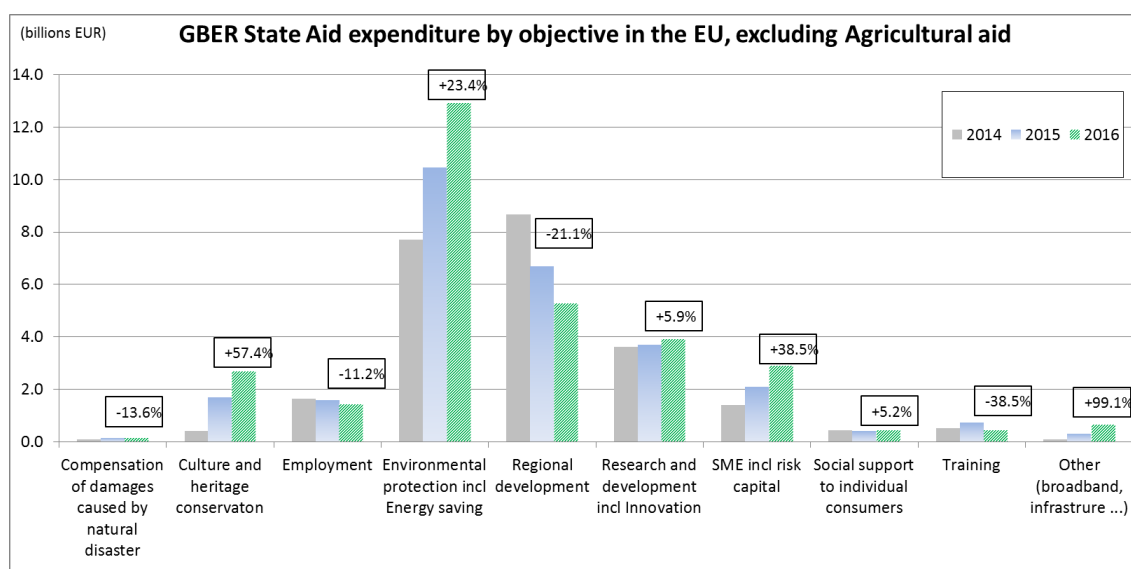

In addition to broadening the categories already covered by the previous Block Exemption Regulation, the 2014 GBER has introduced new categories of aid, namely aid to innovation clusters and aid to process and organisational innovation, aid schemes to make good the damage caused by natural disasters, social aid for transport residents of remote regions, aid for broadband infrastructure, aid for culture and heritage conservation, including aid schemes for audio-visual works, aid for sport and multifunctional recreational infrastructures, and investment aid for local infrastructure.

Total GBER spending in 2016 increased for **broadband and local and multi recreational infrastructures** (+99%), for aid to **culture and heritage conservation** (+57%), for aid to **SMEs and risk finance** (+39%), for **environmental protection and energy savings** (+23%), for **research development and innovation** (+6%) and for social support to individual consumers (+5%) (see [Graph 12](#)).

Looking at the share of spending under GBER, this demonstrates that a large share of aid could be disbursed more quickly (see [Graph 13](#)). In particular:

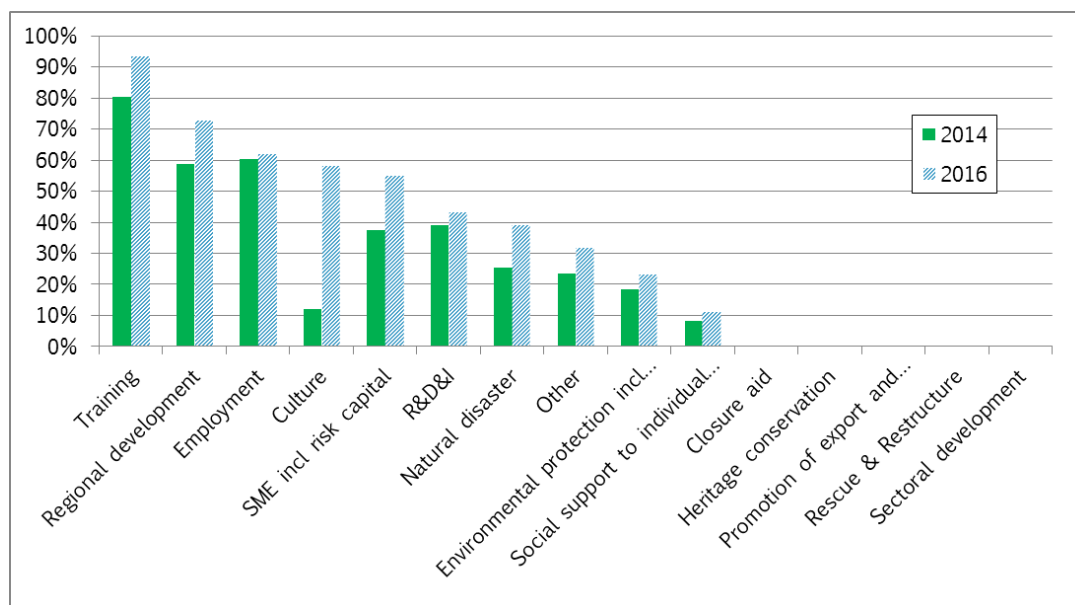
- more than **70%** of spending for **training and regional development** was achieved under GBER
- more than **40%** for **employment, culture, R&D&I and SMEs** (such as aid in the form of risk capital, aid to start-ups and innovative SMEs).

As compared to 2014, the share more than doubled for culture, increased substantially for SMEs (+about 18p.p.), for regional development (+14p.p.) and training (+13 p.p.) and more generally increased for any objective.

These developments demonstrate that the current State aid rules facilitate well-designed aid targeted at common interest objectives and therefore support and complement EU policy initiatives such as i.a. the Europe 2020 Strategy; the Programme for the Competitiveness of Enterprises and SMEs (COSME);

ensuring sufficient flexibility and high amounts of R&D&I aid in a context of strong global competition; or supporting easier deployment of broadband in line with the EU Digital Agenda that sets ambitious goals for broadband infrastructure development to support growth in Europe.

Table 3 details how the different provisions of the 2014 GBER have been used until 2016 at EU level:

- The largest share of cumulated spending was made under environmental protection (Arts. 36-49 GBER) i.e. about 42% of total GBER spending, almost all of which (89%) through Article 44 of GBER i.e. aid in the form of reductions in environmental taxes under Directive 2003/96/EC;
- The second largest share was recorded for regional aid (Arts. 14-15 GBER) representing about 21% of all GBER spending, of which about 60% for investment aid (Art. 14 GBER) and 40% operating aid (Art. 15 GBER);
- A large share of cumulated total GBER spending was also recorded for aid for research, development and innovation (Arts. 25-30 GBER) representing about 12% of GBER spending, of which about 45% distributed under Art. 25(2)(c) GBER experimental development and 40% under Art. 25(2)(b) GBER industrial research;
- SME aid (Arts. 17-24 GBER) represented about 7% of total cumulated GBER spending, reported mostly under Art. 17 GBER investment aid to SMEs (62%) and Art. 21 GBER risk finance aid (26%). Nevertheless, the reported spending for SME objectives more than doubled in 2016 compared to 2015.
- Aid for culture and heritage conservation (Art. 53 GBER) and aid for disadvantaged workers and workers with disabilities (Arts. 32-35 GBER) represented about 7% and 4% of total cumulated GBER spending respectively.

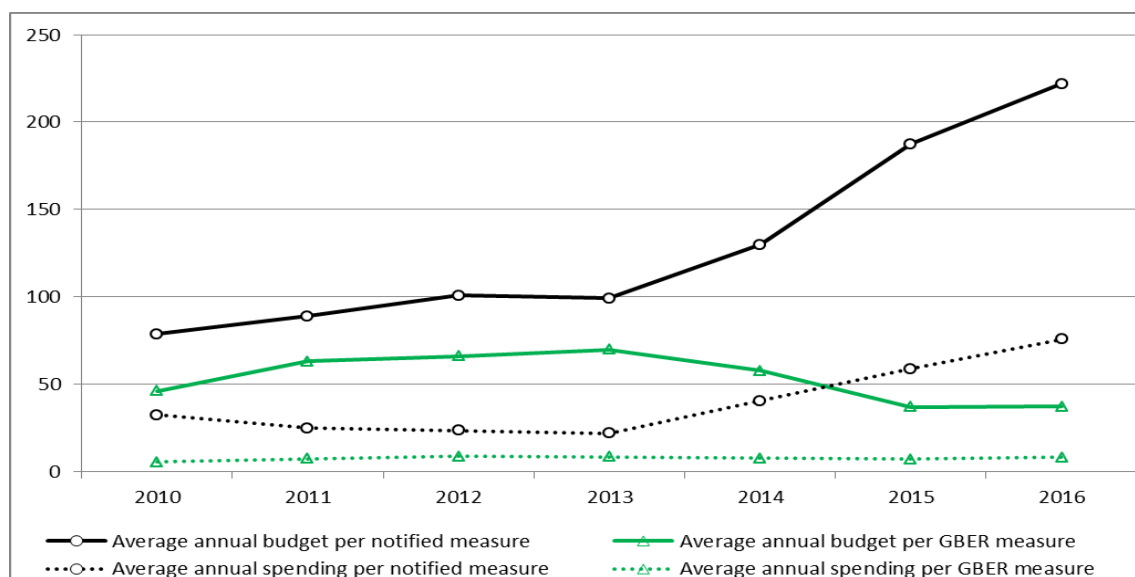
3.2. Provide faster decisions

The large GBER uptake observed implies that State aid measures were processed more rapidly than in the past. In fact, the duration for the assessment of notified measures by the Commission has remained broadly stable at about 5 months over the period 2013-2016 at EU level. However, when taking into account the increasing share of block-exempted measures that can be implemented by Member States without any delay, it appears that, on average, State aid measures can be implemented much more quickly than in the past. Calculated at EU level, the theoretical average duration before possible implementation was respectively about 3 months in 2013 and about 2.5 months in 2016 i.e. a **decrease of 20% of the average duration necessary** before implementing State aid measures.

3.3. Focus enforcement on cases with the biggest impact on the internal market

At the same time, even if the time needed to assess notified measures has remained stable, notified measures that might seriously harm competition or fragment the Single Market are subject to more careful scrutiny and tend to cover bigger budgets and spending than in the past (see [Graph 14](#)), in line with the Commission's approach to be 'big on big and small on small'. In particular, in 2016, the **average annual budget of notified measures implemented was about 222 million EUR**, an increase of about 18% and 124% compared to 2015 and 2013 respectively.

Graph 14 – Average annual budget and spending per implemented measure by type of measure (in million EUR)

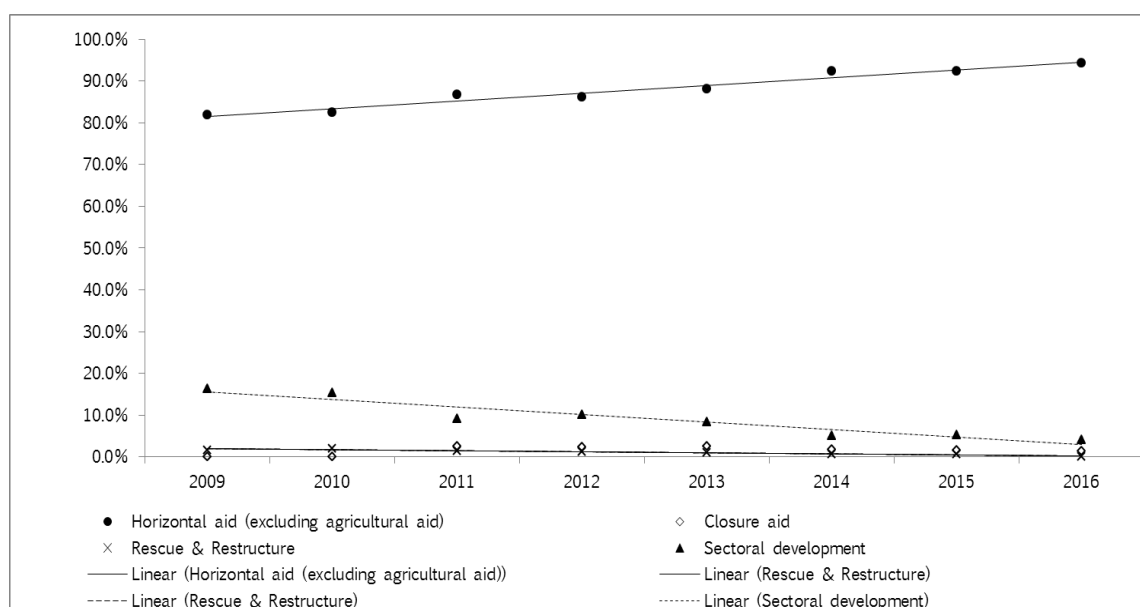

3.4. Foster sustainable, smart and inclusive growth

The new approach allows better allocation of resources and promotes higher efficiency and better quality of policy intervention. In particular, it allows Member States and the Commission to promote "good aid". In 2016, **more than 94% of total State aid spending was allocated to horizontal objectives of common interest** ("good aid"), an increase of about 2p.p. and 12p.p. respectively, compared to 2015 and 2010. State aid spending for rescuing and restructuring companies in difficulty has decreased significantly over the last 5 years, by about 15% annually, highlighting the fact that if aid to companies in difficulty is still permitted, stricter conditions apply to ensure that the most appropriate and transparent restructuring will preserve and sustain the company's long-term viability.

4. AID IN THE CONTEXT OF THE FINANCIAL AND ECONOMIC CRISIS

From 2007 onwards, the European Union faced the most serious financial crisis since its creation. The Commission played a very active role in dealing with the financial crisis and swiftly adapted the State aid framework to allow Member States to put in place an effective response. The restoration of financial stability has been the overarching objective for the Commission, whilst ensuring that State aid and distortions of competition between banks and across Member States are kept to the minimum.

In recent years, the **experience gathered from almost a decade of bank crisis** management was **progressively integrated into dedicated EU policies**. The State aid crisis framework is now operating alongside the EU Bank Recovery and Resolution Directive (BRRD) and the Single Resolution Mechanism Regulation (SRMR). The BRRD requires banks to prepare recovery plans to overcome financial distress and includes rules to ensure that the banks' shareholders and creditors contribute their share to the costs of resolution through a so-called "bail-in" mechanism. As provided in the SRMR as part of the Banking Union framework, a Single Resolution Mechanism was established, taking the form of a new pan-European body for the resolution of banks – the Single Resolution Board – in tandem with the phasing-in of mutualisation of the related costs through the build-up of the Single Resolution Fund. Both pieces of legislation are fully applicable since the beginning of 2016.

In the context of the **new rules**, a **financial institution requiring State aid is considered "failing or likely to fail"** which is the first step in the process that might lead to resolution of a bank. That is the case unless the required State aid takes the form of specific interventions which are explicitly exempted under the new rules. The **specific interventions that can still be implemented with State aid** without leading to resolution include in particular **liquidity or capital support** that is provided as a precautionary buffer. It also remains possible to grant State aid in resolution and in liquidation.

The 2017 scoreboard shows the evolution of State aid measures granted to financial institutions in the years 2008-2016, by aid instrument (see [Table 4, Annexes 4 and 5](#)). The data include both the maximum amounts of aid that EU Member States were allowed to grant (State aid approved) and the amounts of aid actually implemented (State aid used).

As in previous years, the significant difference between aid approved and aid used is due to schemes approved but which have so far not yet been used or used only to a limited extent.

The level of State aid in the financial sector in 2016 is the lowest since the beginning of the crisis both approved and used. No recapitalisation aid was used for any bank for the first time since the beginning of the financial crisis. This can be partly explained by the fact that a number of measures were implemented with some urgency at the end of 2015⁸ when the burden sharing requirements were limited to the shareholders and subordinated debt holders. On 1 January 2016 the full bail-in requirements of the BRRD entered into force, extending the scope of burden sharing to a minimum 8% of total liabilities including if necessary senior unsecured creditors. In addition, the stress test having taken place in 2016 forced some banks to seek aid, which was approved and granted in 2017. A corresponding increase of the amount of recapitalisation aid used is expected for 2017.

For liquidity aid, it is important to keep in mind that, as in the past, most of that aid has been approved in the form of liquidity support schemes. In 2016, some schemes were put in place as a contingency measure, notably in June 2016 in the context of the UK referendum when the market was caught by surprise and tensions appeared in the funding market. In the end, that contingency support was not used.

The largest part of the figure of EUR 123 billion reported as liquidity aid used is not entirely new liquidity support granted in 2016 but rather outstanding instruments that have been issued mainly at the peak of the crisis and have not yet reached maturity. Moreover, the remaining liquidity aid used in 2016 is linked to either specific institutions (i.e. Dexia) or the situation in specific countries (i.e. Greece). Overall, this development illustrates that in 2016 the **European banking sector is relying less and less on government guarantees for liquidity support**, as it is able to find the necessary liquidity on the market

In 2016, the Commission took 28 State aid decisions, of which 19 introduced or prolonged schemes and 2 approved liquidity support measures.

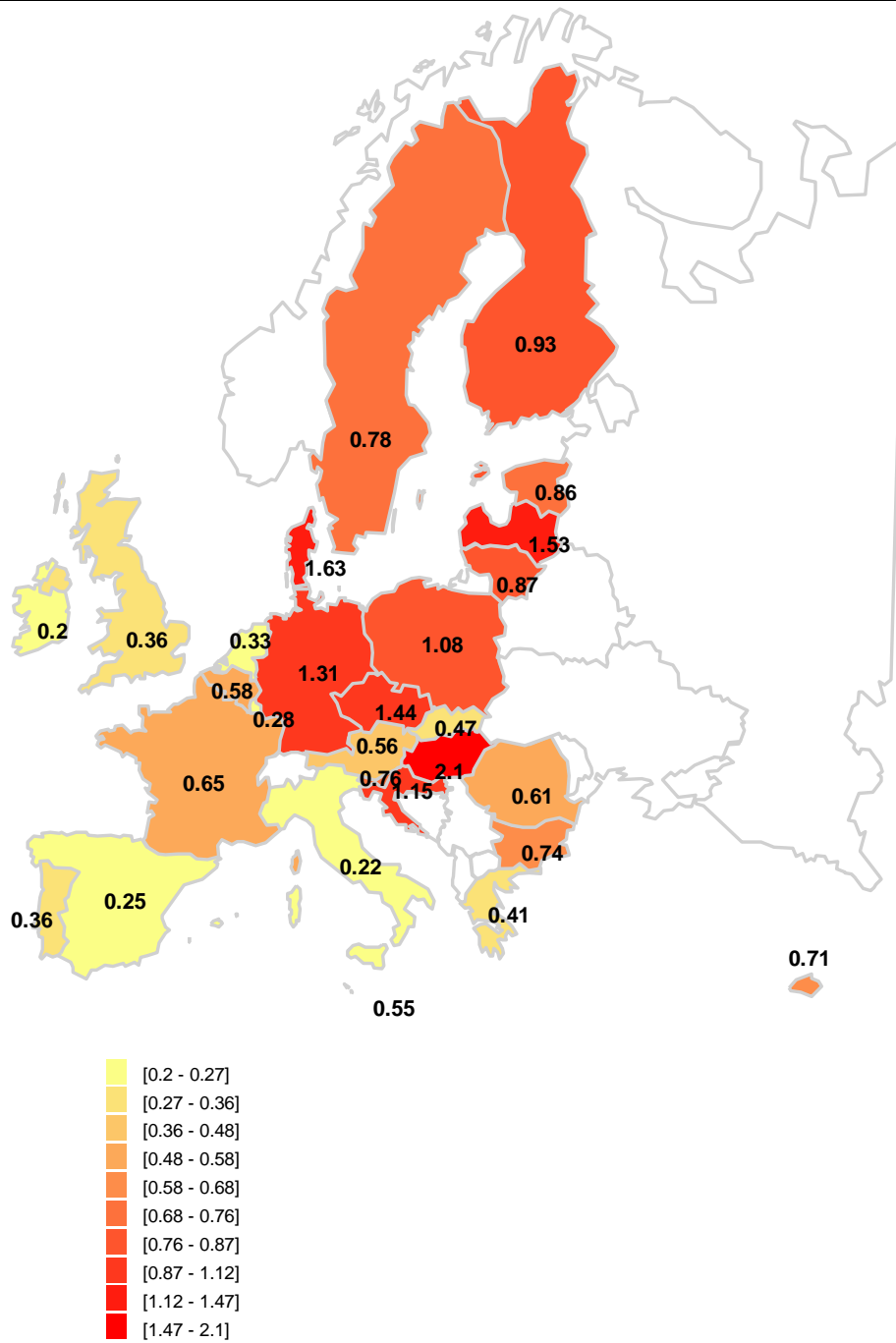

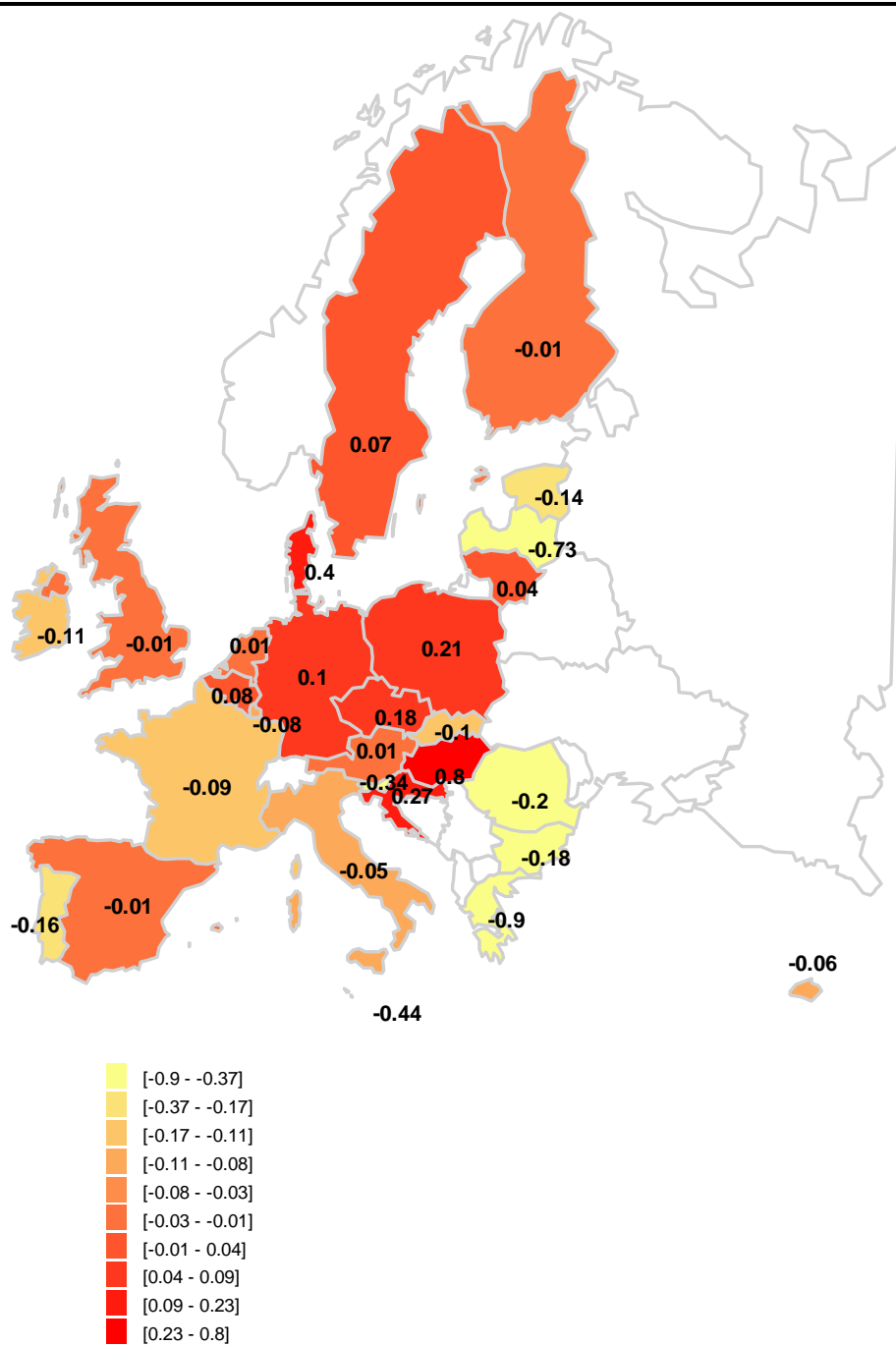

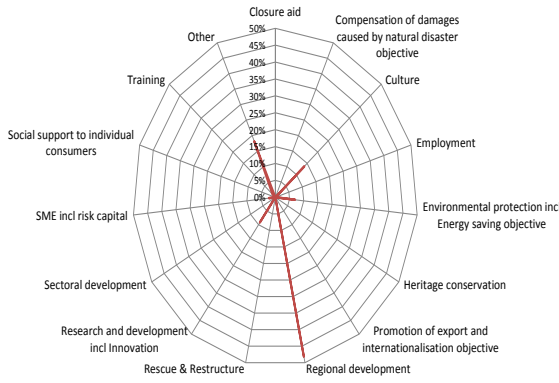








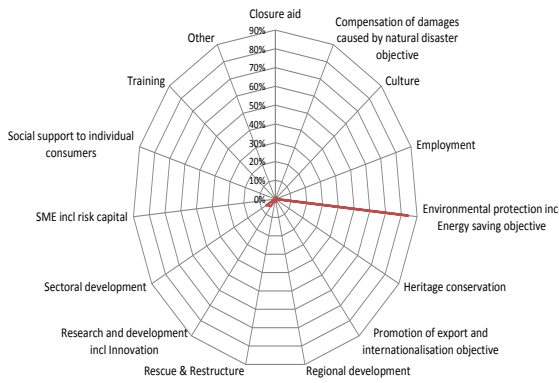
Share of SA spending by objective - Slovakia - 2016



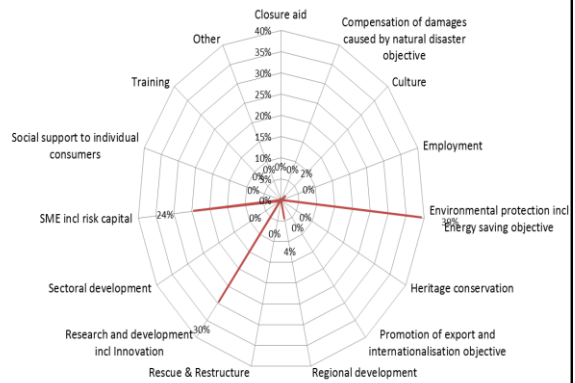
Share of SA spending by objective - Finland - 2016



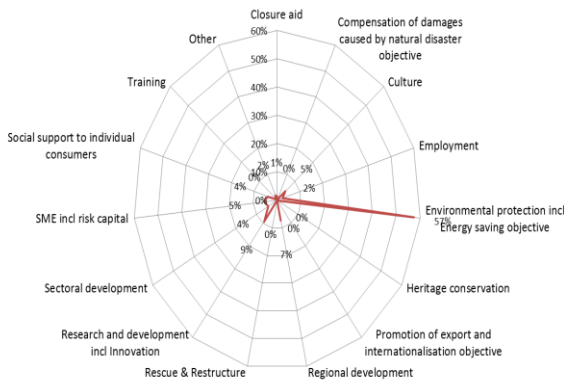
Share of SA spending by objective - Sweden - 2016
